The 2014 Annual Meeting of Shareholders of UniFirst Corporation will be held on Tuesday, January 14, 2014 at the corporate offices of UniFirst Corporation, located at 68 Jonspin Road, Wilmington, Massachusetts 01887, at 10:00 a.m. Eastern Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** all of the nominees set forth in Proposal 1 and **FOR** Proposals 2 and 3:

1. Election of three (3) Class II Directors, nominated by the Board of Directors, each to serve for a term of three years until the 2017 Annual Meeting of Shareholders and until their respective successors are duly elected and qualified.

2. Approval of the UniFirst Corporation CEO Cash Incentive Bonus Plan.
3. Ratification of appointment of Ernst & Young LLP as the Company's independent registered public accounting firm for the fiscal year ending August 30, 2014.
4. In their discretion, the proxies are authorized to vote upon any other matters that may properly come before the meeting or any adjournment or postponement thereof.
